I. Aim and Content: The main aim of this course is to develop the students' ability to understand the social, political, cultural, intellectual and literary climates of the Victorian era which is significant with its richness of forms, language and content. In order to achieve this aim, detailed analysis of the novels will cover a large place throughout the course.

Mary Shelley - *Frankenstein* (1818)

Emily Brontë - *Wuthering Heights* (1847)

Charles Dickens - *Hard Times* (1854)

George Eliot - *Silas Marner* (1861)

Thomas Hardy - *Tess of the d'Urbervilles* (1891)

III. Course Outline:

Week I-II (Sept. 23, Sept. 30): Background to the novel, the Victorian novel, the importance of this age in the novel genre, the characteristics of the Victorian period and novelists.

Week III (Oct. 7): Official holiday.

Week IV (Oct. 14): Mary Shelley, her literary importance and the critical appreciation of *Frankenstein*

Week V (Oct. 21): Midterm I

Week VI-VII (Oct. 28, Nov. 4): Emily Brontë, her literary importance and the critical appreciation of *Wuthering Heights*

Week VIII-IX (Nov. 11, Nov. 18): Charles Dickens, his literary importance and the critical appreciation of *Hard Times*

Week X (Nov. 25): Midterm II

Week XI-XII (Dec. 2, Dec. 9): George Eliot, her literary importance and the critical appreciation of *Silas Marner*

Week XIII-XIV (Dec. 16, Dec. 23): Thomas Hardy, his literary importance and the critical appreciation of *Tess of the d'Urbervilles*

IV. Method of Instruction: The course will begin with introductory lectures which will later on be followed by a close study of the novels through critical discussions in the class room.

V. Requirements: Full attendance is unconditionally required. More than 11 hours of absence will result in F1. The students are expected to read the novels in advance. Reading secondary sources related to the Victorian era and the novels is essential to broaden the students' perspectives.

VI. Assessments: There will be two midterm examinations, study questions, a term paper (up to 5 pages, MLA style), and a final exam. Participation to class discussions will make up 5% of the total grade. In grading the exam papers %25 of the total mark will be taken off for grammar mistakes and writing errors.
